In the event any provision of this contract, including all its covenants and conditions, is breached by Adopter, and/or any misrepresentations have been made by Adopter, GDRNE has the right to rescind this contract and Adopter must return the dog to GDRNE. If Adopter fails to return the dog, GDRNE has the right to seek a court order for return of the dog and seek liquidated damages from Adopter in the amount of \$1,000 plus any court costs or attorney's fees. Payment of damages shall not excuse Adopter from returning the dog to GDRNE.				
16.	This agreement shall inure to the benefit of and be binding upon Adopter and GDRNE and their successors or beneficiaries. Both parties have fully read and understood all of the agreement, which sets forth all promises, conditions, and understandings, oral or written.
